BROWN DOG TICKS and FLEAS in Buildings: Apply in infested areas such as pet beds and resting quarters, nearby cracks and crevices, under the edges of rugs and floor coverings, between and under cushions of upholstered furniture and other areas where these pest may be present. Old bedding of pets should be removed and replace with fresh bedding after treatment of pet areas. Do not use directly on pets.

SPIDERS: Apply along and behind baseboards, to window and doorframes, corners, pipes, storage localities, attics, crawl spaces and other areas over which these pests may crawl.
